## Resolution

I- Resolved that Clauses 1 & 8 of the Articles of Association be amended as under:

In Clause 1(a)(i) and Clause 1(a)(ii) the following line be deleted:

“The term includes editions of these newspapers being brought out from other than Metropolitan Centers”.

**Clause 1(a)(i):** The existing Clause reads as under :

i) “Metropolitan A Dailies, i.e. daily newspapers publishing from all the three Metropolitan Centers i.e. Karachi, Lahore, Rawalpindi / Islamabad. The term includes editions of these newspapers being brought out from other than Metropolitan Centers.”

After amendment, the Clause 1(a)(i) will read as under:

*i) “Metropolitan A Dailies, i.e. daily newspapers publishing from all the three Metropolitan Centers i.e. Karachi, Lahore, Rawalpindi / Islamabad.*

**Clause 1(a)(ii):** The existing Clause reads as under :

ii) Metropolitan B Dailies, i.e. daily newspapers, other than Metropolitan A Dailies, publishing from one of the Metropolitan Centers i.e. Karachi, Lahore, Rawalpindi/Islamabad. The term includes editions of these newspapers being brought out from other than Metropolitan Centers.

After amendment, the Clause 1(a)(ii) will read as under:

*ii) Metropolitan B Dailies, i.e. daily newspapers, other than Metropolitan A Dailies, publishing from one of the Metropolitan Centers i.e. Karachi, Lahore, Rawalpindi/Islamabad.*

II- Resolved that the Clause 8 be amended to authorize the Executive Committee to decide annual subscription rates for all categories of member publications from time to time.

### **Amendment in Clause (8)**

The existing Clause is read as under:

“ There shall be payable in advance for each year an annual subscription of Rs.25,000/- in case the member is a Metropolitan 'A' Daily newspaper, Rs.5,000/- in case the member is Metropolitan 'B' daily newspaper, Rs.2,500/- in case the member is a regional newspaper and Rs.2,000/- in case the member is a periodical.”

The Clause 8 after amendment will read as under:

*“There shall be payable in advance for each year an annual subscription as decided by the Executive Committee from time to time”*
